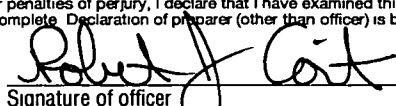

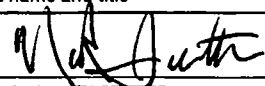

THE THURSTON COUNTY FOOD BANKS MISSION IS TO ELIMINATE HUNGER IN THURSTON COUNTY. THE FOOD BANK IS GOVERNED BY A VOLUNTEER BOARD OF DIRECTORS MADE UP OF COMMUNITY LEADERS. OUR SERVICE AREA IS THE URBAN CORE AND GROWTH AREAS AROUND LACEY, OLYMPIA AND TUMWATER. WE WORK CLOSELY WITH THE RURAL FOOD BANKS IN ROCHESTER, TENINO AND YELM. COLLABORATIONS INCLUDE ACTING AS THE LEAD AGENCY FOR THE EMERGENCY FOOD ASSISTANCE PROGRAM, ACCESSING FOOD THROUGH FOOD LIFELINE, AS WELL AS PROVIDING FOOD AND TECHNICAL SUPPORT TO THE SMALLER RURAL OPERATIONS.

THE THURSTON COUNTY FOOD BANK SERVES 10,000 FAMILIES ANNUALLY, OVER 37,000 INDIVIDUALS. HALF OF OUR CLIENTS ARE CHILDREN.

THE "FORKIDS" PROGRAM - THE BACKPACK PROGRAM IS A COLLABORATIVE EFFORT UNITING LOCAL SERVICE PROVIDERS, SCHOOL DISTRICTS, AND THE COMMUNITY TO ENSURE THAT CHILDREN CONTINUE TO RECEIVE FOOD OUTSIDE OF SCHOOL. THE FOOD BANK USES A CHILD'S SCHOOL BACKPACK AS A DELIVERY SYSTEM FOR A NUMBER OF HUMAN SERVICES TARGETING SCHOOL AGE CHILDREN. THE FOOD BAGS ARE DELIVERED EACH WEEK TO STAFF AT LOCAL SCHOOLS WHERE THEY ARE PLACED IN BACKPACKS. STUDENTS RETRIEVE THE FOOD FROM A COUNSELOR'S OFFICE, WHERE THE TRANSACTION CAN REMAIN PRIVATE.

THE THURSTON COUNTY FOOD BANK'S PROGRAM PRIMARY GOAL IS TO BRIDGE THE NUTRITION GAP CHILDREN FACE EACH WEEKEND WHEN THEY ARE UNABLE TO ACCESS THE FREE AND REDUCED SCHOOL MEAL PROGRAM. IT IS BY PARTNERING WITH
