Through the 24/7 crisis phone line, 251-7273, the Rape Crisis Center provided immediate crisis response to over 1,200 callers, and responded with in-person advocacy for over 360 accompaniments to the hospital or police station

Rape Crisis Center counselors provided free individual counseling for over 130 survivors of sexual assault, while an additional 155 clients participated in support groups designed to help them heal from the trauma of rape or childhood sexual abuse.
