Scholarships and clerkships- Sarah T Hughes Diversity ScholarshipsThis program addresses the identified need to increase diversity among the number of practicing attorneys in our community Scholarships are awarded each year to outstanding minority students entering law school at SMU and who plan on remaining in Dallas upon graduation Renewable each year upon achieving satisfactory grade point average Currently there are 6 Hughes Scholars in law school included in the overall total of 44 Hughes Scholars - Donald C McCleary Leadership ScholarshipAwarded to a second year law student who has demonstrated the leadership qualities consistent with the example set by Donald McCleary Giving back to the community and a willingness to embrace a diversity of ideas were important leadership characteristics demonstrated by Don McCleary - Collins ClerkshipsAn annual program that allows minority students to complete a clerkship during the summer Clerkships are provided at the Supreme Court of Texas, the Fifth District Court of Appeals, the 14th District Court, the City Attorney’s office, the District Attorney’s office and the Public Defender’s office This opportunity exposes the student to mentors, to potential job opportunities and to work expenences that will add value to their job prospects upon graduation Generally 8 to 10 students each year are selected for the program - Justice James Baker ClerkshipThis program provides a second year law student a clerkship opportunity at the Supreme Court of Texas under Chief Justice Wallace Jefferson This opportunity exposes the student to the appellate process of our legal system and provides a unique opportunity to an exceptional law student who has demonstrated excellent writing skills and leadership qualities - Philbin Awards for Excellence in Legal ReportingRecognition program for journalists’ work demonstrating excellence in legal reporting Annual cash awards and plaques are awarded in eight different categories including internet, radio, print, and television reporting Encouraging excellence in reporting legal issues is an important aspect to the furtherance of justice in our community

Grants- Texas High School Mock Trial ProgramInvolves high school students in law focused education and a respect for the law Supports the statewide mock trial competition held by the Dallas Bar Association where 150 teams compete on a statewide level in Dallas In its 30 year history, 107,000 teens have been involved in the mock trial experience - Oral History ProjectAn ongoing project to preserve the rich histories of senior lawyers and the Dallas legal community In 2009 twelve lawyers were video taped for the project - Legal LineSupports the twice monthly, community-focused, free legal service available for people to access via the telephone Citizens can speak to an attorney, free of charge to receive legal guidance with their issues With the economic downturn, this service was utilized to its fullest by local citizens to discuss employment issues, bankruptcy concerns, real estate problems with home ownership and eviction notices Volunteer attorneys assisted over 1000 people this year via the Legal Line program - 100 Presidents of the Dallas Bar AssociationIn keeping with preserving the history of the Dallas legal community, this project honors the 100 year history of the Dallas Bar Association with the publication of this book Noted author and professor, Darwin Payne researched the history and wrote short bios of the 100 Presidents of the Dallas Bar Association and their accomplishments in the community and legal profession - Minority Attorney ProgramSupports a one day program of seminars and presentations designed to meet the needs of minority and female, solo and small practices Business practices, strategy development, and financial policies are a few of the topics included in the program with the goal to enhance the successful growth of a small business - law practice - with minority and female ownership - Law Student Professionalism ProgramSummer Law Clerks (current law students) attend a professionalism program addressing issues facing law students and new lawyers Presentations include mentoring, business etiquette, panel discussions with judges 200 students are involved - Transition to Law Practice ProgramA 12 month mentorship program for new attorneys which guides them through professional ethics, business strategy, legal procedures , etc as they begin their practice of law It is a unique program, that serves as a model for the State of Texas and the American Bar Association Over 200 new attorneys are enrolled in the program and matched with a mentor Monthly educational programs are held to cover specific aspects of practicing law as a new attorney - LAW JAM 2This benefit musical performance by lawyer bands raises funds for the Dallas Volunteer Attorney Program which provides pro bono legal services to the underserved - Summer Law Intern ProgramProvides 35 high school students an introduction to the legal profession and shows the students the various opportunities which are available to them if they apply themselves in school Students attend educational events during the summer and are matched with local law firms for summer employment This is often the first time the students are exposed to a professional environment - Clerk and Coordinator SeminarSupports a one day seminar for 80 clerks and coordinators of the Dallas County Court system which focuses on customer service, professionalism and teambuilding Local judiciary lead small group discussions in the afternoon following lectures in the morning to discuss better ways to assist citizens through the court system - Clerk Coordinator Awards LuncheonProgram focused on recognizing customer service excellence provided by the Clerks and Coordinators employed in Dallas County courts The awards luncheon recognizes outstanding customer service and competence of the clerks in managing the citizen experience with the legal system

- Dallas Independent School District "Appealing to the Public" ProgramAllows over 300 high school students, interested in a law or criminal justice career, the unique opportunity to hear actual oral arguments presented before the justices of the Criminal Court of Appeals of Texas Students are briefed by volunteer attorneys before the arguments with a wrap up presentation after the arguments The purpose is to increase students’ level of understanding of the legal system and to observe an appellate case involving the crime of capital murder One Justice opens the program by giving an overview of the organization of the courts in the State of Texas so the students can learn the appeal process and what it means - E-Mentoring, Esq - Dallas Independent School District StudentsSupports the E-mentoring program, where local attorneys are matched as mentors with DISD 9th & 10th grade students, with the purpose to reduce the DISD drop-out rate and encourage college attendance 500 DISD students are involved with the E-mentoring program At the end of the program these students are transported by DISD to the Dallas Arts District for tours of area museums and a recognition reception at the Dallas Bar Association - Dallas Independent School District Law Magnet High School - Close Up Program The Close Up Program provides high school students a "hands-on" experience in learning, by engaging the people, processes, bureaucracies and issues in Washington, D C which drive our democracy It promotes responsible and informed participation in the democratic process This grant provides for 1 student scholarship The DBF has supported this program since 1999 - LEAD Program (Leadership Education and Debate Program)This program offers opportunities to DISD students to participate in debate programs throughout the year The numerous benefits that result in debate league participation is well documented especially as it relates to the understanding of public policy and the law The opportunity to participate in a summer debate program is critically important in advancing to the next level of debate This grant would provide assistance to students who might otherwise not be able to afford the tuition costs at the University of North Texas summer debate program
