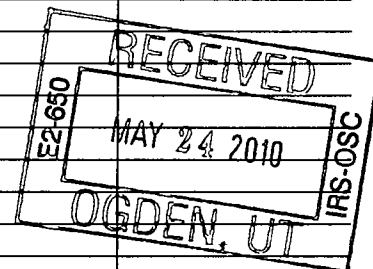

YOUR AGENT MAY EXERCISE THE POWERS GIVEN HERE THROUGHOUT YOUR LIFETIME, EVEN AFTER YOU BECOME INCAPACITATED, UNLESS YOU EXPRESSLY LIMIT THE DURATION OF THESE POWERS OR YOU REVOKE THESE POWERS OR A COURT ACTING ON YOUR BEHALF TERMINATES YOUR AGENT'S AUTHORITY.

YOUR AGENT MUST KEEP YOUR FUNDS SEPARATE FROM YOUR AGENT'S FUNDS.

A COURT CAN TAKE AWAY THE POWERS OF YOUR AGENT IF IT FINDS THAT YOUR AGENT IS NOT ACTING PROPERLY.

This Power of Attorney shall be operative from the date hereof until revoked, and it shall not be affected by (i) my disability or incapacity after the date hereof or (ii) by lapse of time.

I hereby revoke all powers of attorney that I, as Archbishop of Philadelphia, have previously granted, provided, however, that this revocation shall not relate to any general durable power of attorney, health care power of attorney, or advance health care directive I may have executed relating to my person or my individual assets and/or affairs.

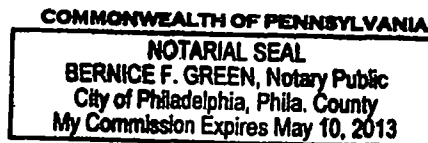
