The YMCA provides high quality child care by providing comprehensive activities for children six weeks old through age 15, drawing on diverse members of the community We participate in the Keystone STARS quality initiative at all nineteen child care locations Woven into the fabric of the YMCA mission is a commitment to strengthening families YMCA child care programs relieve the burden of balancing work and family, and make it possible for parents of children in our care to remain gainfully employed, knowing their children are thriving in a safe, developmentally sound environment The YMCA provides reduced fees for child care services Over \$154,800 was awarded to families to defray their fees this year In addition, the YMCA provides aid to families who need help due to family violence, substance abuse, mental health, etc by collaborating with other social service agencies We also provide family fun events to promote healthy interactions and support between parents and children enrolled in our program Last year, over 2,600 participants were served

Helping people of all ages and abilities develop health in spirit, mind and body is at the core of the YMCA movement Our programs are designed to help people create realistic goals for self-improvement and emphasize disease prevention through regular exercise, proper nutrition, stress management and health education Sports programs for families and adults promote teamwork, interaction and development of social and physical skills The YMCA collaborates with other agencies to provide programs structured specifically for those over 65 years of age, including land and water exercise, as well as an opportunity for social interaction With growing concerns for obesity, the YMCA has made available the Polar Body Age System, to identify "body years" versus chronological years, in an effort to provide incentive and measurable outcomes for members Our aquatic programs start developing physical skills with infancy, with our Mommy/Daddy and Me swim class and continue up through our Arthritis Aquatics class for seniors, our Family Swim program gives adults and children shared time in the pool to appreciate one another and promote intergenerational relationships Our services are offered at affordable fees for the community at large, with reasonable accommodations for those with special needs, and with financial assistance available for those who cannot afford the full fee The YMCA provided more than \$573,000 in financial assistance for YMCA memberships and served over 25,000 participants
