GEEDC provides support for a transitional living home whose mission is to provide a structured living environment and support services designed to help troubled women and their children reclaim, restore and redeem their lives through the process of community living skill development. GEEDC also provides financial assistance to students attending colleges and universities and other training institutions such as Gannon University, Edinboro University, Mercyhurst College, Penn State University, Slippery Rock University, Clarion University and Clark Atlanta University.
