


We focus on the most vulnerable children in need and requires that the child attend school for continued support. For 2009, our sponsors supported 427 children in six countries.

Our Primary School program focuses on improving the quality of education children receive in Primary Schools by providing desks, books, testing, after-school teaching programs and teacher support. We have seen an increase in the number of students qualifying for secondary schools in this program. For 2009, our sponsors supported 2,384 children attending primary schools in four countries.
