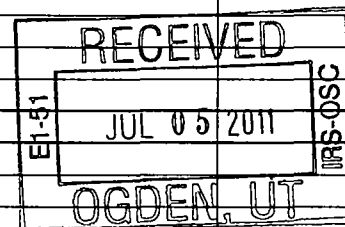

The gain on sale of St. Mary & Exploration Company stock was incorrectly calculated using the foundation's book basis for determining Net Investment Income. Per IRC Sec. 1015, the Net Investment Income basis must be calculated using the donor's basis in the stock. The donor's basis in the stock when donated was \$4/share. On 9/24/09, 17,000 shares were sold for a total cost basis of \$68,000. The adjusted basis results in a gain on the sale of stock of \$468,960. The adjusted gain results in additional tax and penalties owed in the amount \$3,924.
