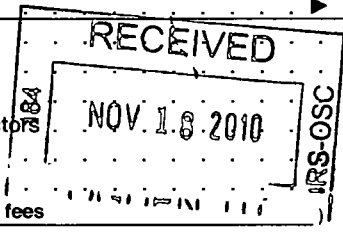

In 2009, Hands for Haiti made grants totaling \$25,610 to support the work of Lakay Fondasyon in Cap Haitien, Haiti. These grants were used to support the needs of indigent young people from Cap Haitien and Sen Rafayel, Haiti, with whom Hands for Haiti has been working since its founding. The support provided by these grants furthered our charitable and educational purposes by providing funds for tuition as well as food, clean water, medical care and related travel costs for these young people. Grants were designated for use as follows:
