Form 990, Part VI, Line 12c	Form 990, Part VI, Line 12c Explanation of Monitoring and Enforcement of Conflicts	The follow ing are the w ritten procedures for addressing the conflict of interest 1 Duty to Disclose In connection w ith any actual or possible conflict of interest, an interested person must disclose the existence of the financial interest and be given the opportunity to disclose all material facts to the directors and members of committees w ith governing board delegated pow ers considering the proposed transaction or arrangement 2 Determining Whether a Conflict of Interest Exists After disclosure of the financial interest and all material facts, and after any discussion w ith the interested person, he/she shall leave the governing board or committee meeting w hile the determination of a conflict of interest is discussed and voted upon The remaining board or committee members shall decide if a conflict of interest exists 3 Procedures for Addressing the Conflict of Interest a An interested person may make a presentation at the governing board or committee meeting, but after the presentation, he/she shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement involving the possible conflict of interest b The chairperson of the governing board or committee shall, if appropriate, appoint a disinterested person or committee to investigate alternatives to the proposed transaction or arrangement c After exercising due diligence, the governing board or committee shall determine w hether the Organization can obtain w ith reasonable efforts a more advantageous transaction or arrangement from a person or entity that w ould not give rise to a conflict of interest d If a more advantageous transaction or arrangement is not reasonably possible under circumstances not producing a conflict of interest, the governing board or committee shall determine by a majority vote of the disinterested directors w hether the transaction or arrangement is in the Organization's best interest, for its ow n benefit, and w hether it is fair and reasonable In conformity w ith the above determination it shall make its decision as to w hether to enter into the transaction or arrangement 4 Violations of the Conflict of Interest Policy a If the governing board of committee has reasonable cause to believe a member has failed to disclose actual or possible conflicts of interest, it shall inform the member of the basis for such belief and afford the member an opportunity to explain the alleged failure to disclose b If, after hearing the member's response and after making further investigation as w arranted by the circumstances, the governing board or committee determines the member has failed to disclose an actual or possible conflict of interest, it shall take appropriate disciplinary and corrective action
