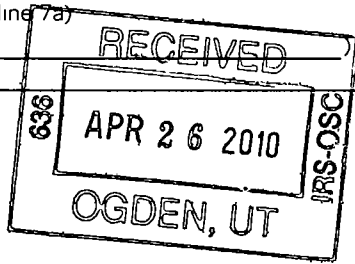

Statement of Program Service Accomplishments

Angels at Risk is the only free program for teenagers and families at risk for drug and alcohol use and abuse on the Westside of Los Angeles. We serve the population from Inglewood to Malibu. Our programs and services are delivered through these six modalities:

- 1) Parent/teen support groups (free to Westside community/schools/informal juvenile court.
- 2) Classroom speakers - storytelling, prevention/education.
- 3) Counselors for on-campus support groups.
- 4) School based assemblies for parents & school based assemblies for teens.
- 5) Generating awareness through media, website, events, 12 step meetings & stories for school papers/websites
- 6) We provide support with crisis management in collaboration with community drug and alcohol resources.

In addition to providing education and support, Angels at Risk also oversees all documentation required for court-referred clients (most of whom come from Santa Monica Juvenile Court).

Although it is hard to quantify in exact numbers, we estimate that we directly impact between 4,000 - 6,000 students, parents and administrators each year. The indirect impact is immeasurable.
