To provide remedial education programs for young adults who were academically disadvantaged by the 14 year civil war in Liberia

PART III:

ORGANIZATIONS' PRIMARY PROGRAMS:

- 1 **ADULT EDUCATION CENTER** – Completed structural repairs to severely war damaged Adult Education Center (AEC) in Buchanan, Liberia
Purchased furniture and educational supplies, equipped Project Leader with resources and specific training necessary for administration of programs, and funded tutors, janitorial services and security

- 2 **SCHOLARSHIP PROGRAMS** – Finalized university scholarship program goals and structure, equal opportunity policies, application and terms
Nine recipients were selected at three Liberian universities, with funding for tuition and fees initiated in August 2010, all recipients are in pursuit of careers identified as in short supply in post-war Liberia, contributing to the nation's re-building goals

- 3 **EDUCATION PROGRAMS** – Launched adult college preparatory courses, individual academic tutoring, and introductory computer training programs at AEC
Offered individual counseling for post-war trauma and hosted small group gatherings to address practical skills and issues of reintegration into Liberian society
Initiation, formal process and approval of a student association on the Cuttington University campus in Suakoko, Liberia
Chapter hosted two leadership seminars, college fair for regional high school students and peer tutoring programs
