Bridge2Rwanda supported the development of Muhabura University. This is a Rwandan registered corporation with a mission to provide higher education to the youth of Rwanda. Projects supported by Bridge2Rwanda included construction and renovation projects, compensation for the CEO and construction manager, and overhead items related to establishment.

4b (Code: ☐) (Expenses \$ 119,932. including grants of \$ 7,500.) (Revenue \$)

Supported the education and leadership development of qualified students living in Rwanda, Africa including orphans and those financially disadvantaged.

4c (Code: ☐) (Expenses \$ 95,612. including grants of \$ 39,500.) (Revenue \$)

Supported the Sonrise School; a private school in Musanze, Rwanda which is operated by the Shiya diocese of the Anglican Church of Rwanda. There are a total of 1,018 pupils within the primary and secondary schools. The majority of these students are orphans and most students are financially disadvantaged.

In 2009, Bridge2Rwanda granted money for the completion of a science lab and a clean water supply system; shipping and distribution costs for a container of supplies shipped in 2009; and the creation of English language and leadership development programs.
