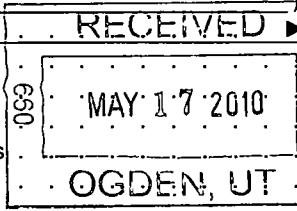



**BE IT KNOWN**, that on this 31st day of December 2009;

**BEFORE ME**, the undersigned Notary Public, and in the presence of the witnesses hereinafter undersigned:

**PERSONALLY CAME AND APPEARED,**

**CHRISTIAN N. WEILER** a person of the full age of majority and resident of the Parish of Jefferson, State of Louisiana, (Appearer) and appearing herein as Secretary of Dancing for Dystrophy, a Louisiana Non Profit Corporation; and

**WILLIAM P. WYNNE** a person of the full age of majority and resident of the Parish of Orleans, State of Louisiana, (Appearer) and appearing herein as General Counsel of Dancing for Dystrophy, a Louisiana Non Profit Corporation;

Who collectively declared to me, Notary, in the presence of the undersigned competent witnesses, that availing themselves of the provisions of the Louisiana Nonprofit Corporation Law, they declare as follows in reference to such Corporation:

- 1) An Amendment to Article I to the Amended and Restated Articles of Incorporation of Dancing for Dystrophy has been approved by the unanimous vote of the Board of Directors of Dancing for Dystrophy ("Directors") in accordance with Article XII of the Amended and Restated Articles of Incorporation of Dancing for Dystrophy at a special meeting held on December 19, 2009;
- 2) The Amendment to Article I to the Amended and Restated Articles of Incorporation of Dancing for Dystrophy has been effected in conformity with law;




