28 We created the forms and processes for accreditation, and general operating standards/applications, and several animal care standards/applications. We accredited/verified 8 sanctuaries, with another 45 underway, and refined our process. We provided webinars on grant writing (58 in attendance), training for site evaluators (20), and other topics (18). (Note that many participants can be represented by each dial-in number reported.) We visited 9 sanctuaries. GFAS produced a website with 19 sections, a brochure and a booth exhibit. GFAS presented at three conferences, for a total of 6 presentations, and exhibited twice. We helped place more than 1520 animals. GFAS directly helped sanctuaries obtain \$40,500 in grant awards. We began the Captive Wild Animal Protection Campaign. We created the GFAS Carole Noon Award for Sanctuary Excellence, and gave our first award, along with a \$5000 cash award. GFAS met with Pan African Sanctuary Alliance members and added a GFAS coordinator for Europe.
