Education and peer support are critical to the success of these activities and thus services will be rendered to facilitate learning. Each household will ultimately be self-sufficient in these basic areas and be able to mentor and give back to others in the communities. Additionally, the community at large will be mobilized to support these vulnerable household through literacy classes, community forums and community celebration.
