4CORE provides weatherization services in a 5 county region in SW Colorado with a grant awarded by the State of Colorado Governor's Energy Office. As a result, 4CORE entered into subcontractor agreements creating 9 new jobs in the community and adding 6 new staff positions at 4CORE.

4CORE experienced exponential growth and continued mission expansion in 2009. Education and outreach activities increased, resulting in 6,447 communications via telephone calls, emails, e-newsletters and social marketing and over one million press impressions. 1,899 people attended 4CORE workshops, presentations and events in 2009.

Greenhouse gas emissions were reduced by 2,730 metric tons, the equivalency of 641 cars taken off the road or the planting of 125,000 trees. 4CORE provided \$136,000 in rebates to 199 community residents and businesses.
