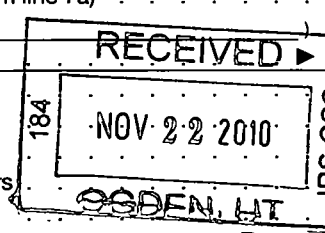



Part I, Line 10 Grants

For 2009, Water to Thrive made grants totaling \$151,525 for the construction of 59 community water projects located in rural Ethiopia and Sierra Leon. The grants were managed through the following three implementing partners:

- 1) A Glimmer of Hope Foundation, Austin, TX (also a 501 c (3)). Glimmer of Hope is an implementation partner in Ethiopia and manages the implementation of our water projects with its staff in Addis Abba;
 - \$30,000, Central Ethiopia, Oromia Region, Deep borehole project with 10 community water points
 - \$4,121, Western Ethiopia, Kellem zone, 1 hand dug well for school
 - \$20,571, North Western Ethiopia, Amhara Region, 10 projects, hand dug wells and shallow bore holes
 - \$36,804, Western Ethiopia, Kellem zone, 10 spring protection systems
 - \$15,016, Northern Ethiopia, Tigray Region, 7 hand dug wells

- 2) The Development and Social Services Commission (DASSC) of the Ethiopian Evangelical Church of Mekane Yesus , Addis Ababa, Ethiopia. DASSC manages and coordinates the project implementation with local synod-level DASSC organizations.
 - \$30,013, Central Ethiopia, Central Gibe Synod, 11 spring protection systems

- 3) The Evangelical Lutheran Church of Sierra Leone (ELCSL), Freetown, Sierra Leone. ELCSL manages and coordinates the project implementation with local synod-level organizations throughout Sierra Leone.
 - \$15,000, Sierra Leone, 10 spring protection systems

The payments reflected above are progress payments and do not represent the total cost of the projects. Some projects were completed in 2009 and others will extend into 2010. These projects provided clean disease-free water for approximately 30,000 rural Africans who previously had never had access to safe water.
