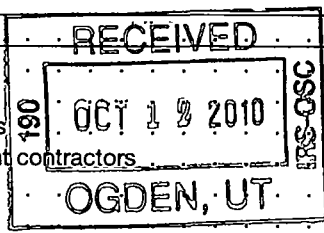



The RCS Educational Foundation, Inc. reached out to schools, science centers, and community organizations. The benefits of E3 Student-Centered Teaching were shared with over 100 teachers and facility members. Program participants include students from the 4th through 12th grades. Through these programs, RCSEF<sup>i</sup> encouraged and motivated over 1,000 students to pursue careers in STEM. Survey results indicate an increased interest in STEM of over 40% and a 5% increase in students declaring to pursue STEM careers.
