Tasked with leading the state's obesity prevention efforts, LiveWell Colorado (LWC) is implementing an aggressive five-year strategic plan that was developed with input from hundreds of experts and stakeholders. Priority action goals are focused in the following areas: Funding local community coalitions throughout the state focused on healthy eating and active living strategies; Informing and advancing multi-sector policy efforts with key stakeholders at the local, state and national levels; Leading social marketing initiatives that inspire a culture shift and motivate sustainable healthy behavior changes. These goals are supported by the underlying objectives of reducing health disparities, building synergy and reducing duplication of efforts among organizations, supporting promising practices and ensuring accountability through rigorous evaluation.

Community Investment LWC’s community investment strategy funds community coalitions working on healthy eating and active living strategies at the local level. In 2009, LiveWell Colorado awarded \$4 million in funding to 25 communities across the state. In addition to financial support, LiveWell Colorado provides technical assistance and opportunities for shared knowledge and collaborations. Since its inception in 2007, the community grants program has benefited more than half a million Coloradans. Supporting our Communities. Unlike typical grant relationships, LWC cultivates rich partnerships with the communities it funds. In addition to financial support provided through a seven-year funding cycle, LiveWell Colorado strives to build capacity in each of the funded communities by offering technical assistance, conducting site visits and providing community networking and training opportunities. In 2009, training agendas included webinars, roundtable discussions on school policy, food systems, early childhood, active community environments and coalition building, as well as networking opportunities and grassroots advocacy training.

Communication To further establish a leadership position, LiveWell Colorado’s communication strategy focused on elevating the issue of obesity among opinion-leaders, stakeholders and the general public, as well as conveying LiveWell Colorado’s approach to tackling the complex obesity epidemic. Media outreach told the story and built credibility. In 2009, LiveWell Colorado reached over 56 million people through media stories. LiveWell Colorado was highlighted in more than 60 newspapers, nearly half were outside the Denver metro area. LiveWell Colorado was featured in 11 stories on nine television stations. Strategic communication tools engaged stakeholders and facilitated discussions. LiveWell Colorado re-launched its website to be more content-rich, interactive and useful to stakeholders. Website visits increased 46 percent in 2009. The e-newsletter subscription base grew 43 percent since March 2009. More than 350 attendees from throughout the country participated in six webinars.

Policy and Education LiveWell Colorado is leading the development of a series of Policy Blueprints which assess current initiatives, recommend actionable strategies, and provide overall direction for statewide efforts regarding specific policy topics. LWC recently released a Food Policy Blueprint, followed by a Worksite Wellness Blueprint and Food Policy Blueprint. Based on input from hundreds of stakeholders and experts across the state, the Food Policy blueprint identifies the most pressing policy needs and opportunities to strengthen access to healthy foods in Colorado. Blueprint tools include: Eight high-priority policy recommendations identified through stakeholder surveys and interviews that will direct future policy efforts; Thirteen criteria and a scoring system for prioritizing food access policy recommendations, and the Searchable Healthy Foods Database that lists ongoing efforts across the state to increase access to healthy food. Worksite Wellness Blueprint. The Worksite Wellness Policy Blueprint assesses the current state of worksite wellness in Colorado and identifies, prioritizes, and guides future efforts. LiveWell Colorado collaborated with the Colorado Physical Activity and Nutrition (COPAN) program at the Colorado Department of Public Health and Environment, which is building a framework to guide employers’ actions. Based on stakeholder feedback garnered from regional focus groups, interviews and surveys, LiveWell Colorado, in partnership with others, will pursue and support the following strategies to promote Colorado worksite wellness efforts: Convene a Colorado Worksite Wellness Leadership group that will bring together content experts from diverse sectors to provide leadership, momentum and coordination in identifying and implementing statewide worksite wellness priorities; Promote a Colorado Worksite Wellness framework which will include steps and resources to build, assess, plan, implement and evaluate worksite wellness programs at the organizational level; Grassroots Advocacy Power Program. The Grassroots Advocacy Power Program (GAPP) is a sophisticated tool that educates and mobilizes grassroots supporters to influence legislation on obesity-related issues. Targeted e-mail action alerts allow advocates to identify their state and federal representatives and directly send them messages urging support or opposition to proposed legislation. Today, GAPP has 370 members. Legislation. Introduction of SB10-106 A critical strategy that emerged from the Food Policy Blueprint and aligned with recommendations from the Centers for Disease Control is the formal establishment of a statewide food policy council. As the first step in implementing the Blueprint, LiveWell Colorado initiated legislation to create the Colorado Food Systems Advisory Council, a diverse body that will advise the advancement and achievement of the eight policy priorities included in the Blueprint. The bill, SB10-106 successfully passed and the council is expected to be seated later this year.
