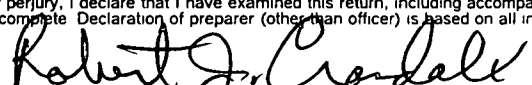
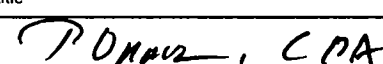

The children range in age from pre-kindergarten through the third grade, are taught by eight teachers and are supported by a principal and one administrator. In addition to the construction of the school, GBBMI supported the drilling of one well to provide drinking water to the school and the construction of 15 latrines for sanitation. Funds were also raised to provide scholarships for students to attend the school.

Mission groups from the United States traveled to the region on two occasions during 2009 to provide training to local Banjara leaders and college students and to assess the additional needs that could be met by GBBMI.

During 2008, GBBMI sponsored six micro-businesses that continued to operate during 2009. These businesses include two grocery stores, one goat herd, two buffalo milking operations and one grain grinding operation.

GBBMI also works to educate congregations in the U.S. about the Banjara people, their culture and their economic need. Two such training meetings were held at United States churches during 2009.
