ENVIRONMENTALLY FRIENDLY OFFICE FURNITURE DISPOSITION - EDUCATE CORPORATIONS AND INSTITUTIONS ABOUT RECYCLING UNWANTED OFFICE FURNITURE, RATHER THAN THROWING IT IN A LANDFILL. THE FURNITURE TRUST TAKES THE DONATED FURNITURE FROM THESE COMPANIES AND DISTRIBUTES THE PRODUCTS TO LOCAL NONPROFITS.

ENVIRONMENTALLY FRIENDLY OFFICE SUPPLY DISPOSITION - EDUCATE CORPORATIONS AND INSTITUTIONS ABOUT RECYCLING THEIR UNWANTED OFFICE SUPPLIES RATHER THAN THROWING THEM IN A DUMPSTER FOR DISPOSAL. THE FURNITURE TRUST COLLECTS AND REDISTRIBUTES OFFICE SUPPLIES TO LOCAL NONPROITS, PRIMARILY SCHOOLS.
