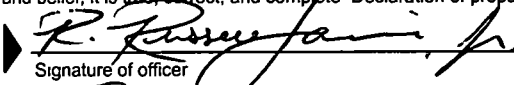

Primary Purpose:

Urban Alliance, Inc. "UA" is organized and operated exclusively for 501 (c) (3) purposes. Its mission is to improve the lives of underprivileged persons living in the City of Hartford, Connecticut, by developing a network of collaboration and support for local churches and Christian organizations that minister and provide social welfare services within the community.

Relationships, resources and research will be mobilized through the UA Network in the form of Network programs that allow participating churches and organizations to access grants, communications support, technical assistance and volunteer support. This assistance will help Network participants succeed in their service, vision and capacity for impacting individuals and families in Hartford.

Line 28 Program Service Accomplishments:

As 2009 was the first full calendar year of operation, Urban Alliance primarily focused on the following activities to further develop the Organization's infrastructure and in preparation of program implementation: a) finalized the service delivery model (based upon service area research data collected), in the form of the Urban Alliance Network and corresponding application process, for providing Network programs and support services to participating churches and ministry organizations; b) continued outreach through dialogue and meetings with potential Network participants; c) started developing the UA grant-making function for Network participants (processes and procedures, eligibility criteria, grant proposal guidelines, etc); d) worked with a design firm to develop Urban Alliance's logo and letterhead and to begin work on the Organization's website which will facilitate and support the UA Network by serving as a tool to engage participants, enabling them to download program documents and materials, complete and submit Network application forms, and upload their organizational documents and grant progress reports to submit to Urban Alliance; and e) received first UA Network Application from a local Hartford ministry organization regarding the opportunity to help enhance and expand drug intervention and rehabilitation services to Hartford adolescents. UA expended \$ 109,571 towards these program service accomplishments during 2009.

Urban Alliance also began recruiting and hiring staff and secured permanent office space located in downtown Hartford.
