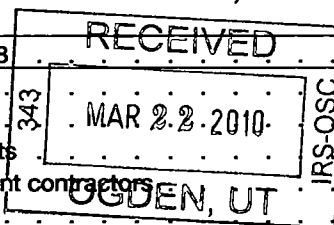

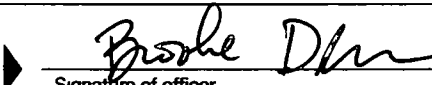

Part V, Question #33: Description of Previously Unreported Activities

Progeny Foundation, Inc. began in the Spring of 2008; however, we were not approved for 501(c)3 status until 2009. The specific activities that were completed in 2008 are listed below in detail.

Athletic Teams: In 2008, our program supported a single basketball team made up of ten kids that had just finished their freshman year of high school. The basketball team practiced twice a week and played tournaments on the weekends. Our tournaments for 2008 took place in Indianapolis, Chicago, Fort Wayne, and Louisville.

Coaching: In 2008, Progeny Foundation provided high quality coaching. The coaching philosophy is to stress teamwork and the sacrifice of individualism in order to be part of a team. The active coaching staff was made up of 6 coaches. None of these coaches received any compensation or retirement benefit contributions. All coaches are non-paid volunteers.

- ✓ David DeRam – average of 20 hours per week coaching
- ✓ Eric Allen – average of 10 hours per week coaching
- ✓ Shon Bolden – average of 10 hours per week strength training the players

Athletic Facilities: Progeny teams participate in a variety of athletic events, practices, and conditioning. In 2008, we rented gym time for individual workouts and practice as well as practiced within one of the local high school gymnasiums.
