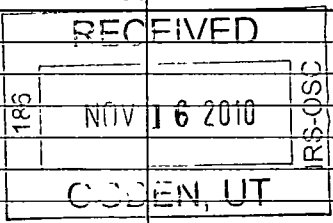



AMENDED AND RESTATED BYLAWS

of

MBK SCHOLARSHIP FOUNDATION INC.

1 MEMBERS

1.1 INITIAL MEMBER

Until his death or the appointment of one or more additional or successor members as provided below, the sole member of the corporation (the "*Initial Member*") will be:

1.2 OTHER MEMBERS

The Initial Member may appoint one or more additional or successor members at any time or from time to time in his sole discretion. Upon the death of the Initial Member, each of his then-surviving children will automatically be appointed a member of the corporation. If upon his death the Initial Member has no surviving children, Mimi OkKyung Kim will automatically be appointed a member of the corporation. Thereafter, the members of the corporation may by majority vote appoint one or more additional or successor members at any time or from time to time in their sole discretion.

1.3 VOTING RIGHTS

Each member will be entitled to one vote on each matter submitted to a vote of the members.

1.4 TERMINATION OF MEMBERSHIP

During his lifetime, the Initial Member may terminate the membership of any other member at any time in his sole discretion. After the death of the Initial Member, his then-surviving children may by majority vote terminate the membership of any member that is not a child of the Initial Member at any time in their sole discretion. If upon his death the Initial Member has no surviving children and, as a result thereof, Mimi OkKyung Kim is automatically appointed a member of the corporation, she may terminate the membership of any other member at any time in her sole discretion.

1.5 RESIGNATION

Any member may resign at any time in his or her sole discretion by filing a written resignation with the board of directors of the corporation.

1.6 NO TRANSFER OF MEMBERSHIP

Membership in this corporation is not transferable or assignable.

1.7 DISSOLUTION OF CORPORATION IS NO MEMBERS

If at any time the corporation has no members, the corporation will be dissolved and its business and affairs promptly wound up, and its assets distributed as provided in the certificate of incorporation of the corporation.

2 BOARD OF DIRECTORS

The board of directors of the corporation will manage the business and affairs of the corporation.

3 OFFICERS

The officers of the corporation will include a president, and may include one or more vice presidents, treasurers, assistant treasurers, secretaries, and assistant secretaries. The same person may hold any two or more offices. Except as otherwise required by applicable law, the articles of incorporation of the corporation, or these by-laws, the management of the corporation will for all purposes be vested in the president, and the president will have the sole authority: (i) to act on behalf of the corporation in connection with the corporation's day-to-day affairs; and (ii) to bind the corporation pursuant to authority expressly granted by these by-laws or expressly authorized by the board of directors. Each officer must possess such qualifications as the board of directors may determine. The board of directors shall appoint the president, and may in its sole discretion appoint one or more vice presidents, treasurers, assistant treasurers, secretaries, and assistant secretaries. Each officer will hold office for such term as the board of directors may direct. Each officer will hold office until such officer's successor has been appointed and qualified or such officer's earlier death or resignation or removal in the manner provided in these by-laws. Any officer may resign at any time by giving written notice to the board of directors or the president. Such resignation will take effect at the time specified in such notice or, if no time is specified, upon receipt thereof by the board of directors or the president, as the case may be. Unless otherwise specified in such notice, acceptance of such resignation will not be necessary to make it effective. All officers and agents of the corporation will be subject to removal, with or without cause, at any time by the board of directors. Unless otherwise determined by the board of directors, each officer will serve a one-year term, commencing on January 1 each year.

4 FISCAL YEAR

The fiscal year of the corporation will begin on the first day of January and end on the last day of December of each year.

5 AMENDMENTS TO BYLAWS

These bylaws may be altered, amended, or repealed and new bylaws may be adopted only by a majority of the members present at any regular meeting of the members of the corporation, or at any special meeting of the members of the corporation, if at least two days' written notice is given of intention to alter, amend, or repeal or to adopt new bylaws at such meeting.
