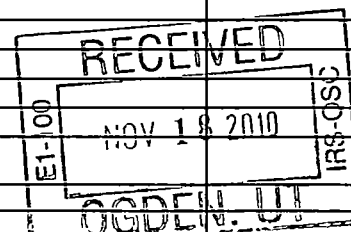

The Foundation is the residual beneficiary of the Estate of Eleanor R. King. The primary asset of the Estate is undeveloped land. The Estate is actively trying to sell the land. However, market conditions in 2009 (and 2010) were not conducive to sale of the land at a reasonable value. The Estate remains open as the Estate continues its efforts to sell the land.

In 2009, the Foundation incurred payroll costs for its President and Secretary under the assumption that the land would be sold by the Estate and the proceeds contributed to the Foundation thereby allowing charitable operations to commence. When it became clear that the land would not be sold these costs were transferred back to the Estate.
