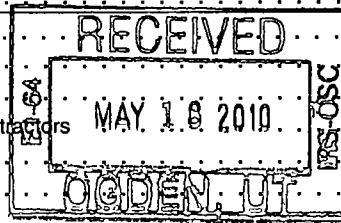




Purpose : To provide an educational tutoring and mentoring program for at-risk inner city minority youth.

First year's activity # 1 : Total Activity at 100% for the first year.
90 % of this organization's total activity

- Where : In the City of Huntsville , AL.
- When : We will begin in Jan. of 2009
- How : We will establish our educational after school tutoring - mentoring programs by utilizing resources and groups within the community.
- a. After school tutoring / mentoring program: Phase one of the program will offer after school academic tutoring to at-risk students . We will concentrate on the academic subject areas of reading comprehension and writing skills. These are academic areas at-risk students have the difficulties in.
The tutoring program will operate Monday thru Thursday from 4:00pm to 6:30pm. To advertise the program ,we will have our organization's board members to make presentations to area schools and youth groups . We will produce informational flyers for distribution at these presentations and will utilize board members for several local church presentations. We also will make several on the air public service announcements and place public service announcements in the local print media outlets.
- b. Recruiting : We will recruit youth participants by appealing directly to local school and classroom teachers , churches and parents groups to find and identify those students who could use this service. We will conduct informational sessions with local school classroom teachers and church groups on the importance of improving academic skills. These initiatives will insure that we will reach our targeted population. Although , we will concentrate on our targeted group , all tutoring activities will be open to the general public .

- **c. Implementation :** To staff the program we will rely heavily on our community volunteers as instructors and mentors. Some board members will also participate as uncompensated staffers. The educational tutoring sessions will be held in local churches. We will start the program in Jan. of 2009 . This schedule will give us an opportunity to fully recruit those inner city at-risk students that need to be in a program of this nature. It will also give us the time to recruit and train as many volunteers - instructors / mentors as possible . We anticipate serving over 30 students during the first six months , with increases as needed. In order to fund our program initiatives , we will submit proposals to foundations , area corporate businesses , and governmental granting agencies.

To fund our educational / mentoring program , we will seek contributions and donations from foundation grants , corporate sponsors and the general public. Funds will be used to support the organization's activities . All financial support will be used to cover programmatic expenses and provide for a wider assortment of future initiatives targeted towards inner city youth . All revenue remaining after programmatic expenses will be put 100% back program services.

- **Administrative Works :** Will constitute 5% of the organization's total activity: Administrative work will be conducted by board members and community volunteers
- **Fundraising Activity :** Will constitute 5% of this organization's total activity : Our board of directors and unpaid volunteers will solicit funding support from the corporate community and foundation grants , and personal appeal , and they will not be compensated for their efforts .
