





<p>Botswana project Sister Shops-Botswana and beyond Like many non profits operating in Africa, we believe that the bicycle is a unique way towards solving many economic, social and health problems in Africa Lack of transportation outside of the main cities makes it difficult for children to get to school, for adults to find work and for AIDS patients to get the medical attention they need Bicycles make remote villages much more accessible, thereby improving the conditions of the inhabitants In the interest of creating a long-term and self sufficient improvement in the lives of these impoverished citizens, we have endeavored to create a sustainable network of bicycle infrastructure, including the availability and affordability of bikes, widely available technical and repair know-how, and the availability of tools and necessary parts Mike's Bikes Foundation has been working closely with a bike shop owner named Jonathan "Bones" Moletsane in Gabarone, Botswana, to give him the tools and capital that he needs to start his business Mr Moletsane is an AIDS relief worker and has completed a bicycle academy in Namibia We have provided Mr Moletsane with over 160 hours of one-on-one mentoring on the fine details of owning and operating a bike shop including sales, customer service and successful business practice, over 400 bikes, tools to use for bicycle repair, and sufficient funds to establish a shop space in Gabarone We intend to continue supporting Mr Moletsane as he builds his business and reaches out to other potential bike shop owners in the surrounding area This activity has been our main focus to this point, and has required two separate trips from California to Botswana for Ken Martin and Matt Adams as well as many telephone calls We have identified an individual in Namibia who will be our second Sister Shop We will go through the same process we've been through with Mr Moletsane, including the mentoring, bike drive and funding It is our hope to continue identifying individuals who are poised to operate bike shops and provide similar assistance to them in the future In doing so, we will achieve our goal of developing a sustainable transportation infrastructure based on the bicycle</p>	\$140,307		\$90,794
