Mission Program - Expansion International lead two mission teams of volunteers to Kenya in 2009. The teams provided medical services and medicines to 1,270 patients and distributed vitamins and parasite medications to over 10,000 people. They hosted children's programs for 4,500 children and conducted a Sunday school teacher's conference for 200 teachers. As well, teams distributed 70,000 lbs of food to refugees and others in need.

4b (Code _____) (Expenses \$ 6,195. including grants of \$ _____) (Revenue \$ _____)

Scholarship Program - In Kenya, public school is provided through 8th grade, students must then find a way to pay \$420 for a good highschool education. In Kenya where the monthly wage for a laborer is \$70, raising the funds to attend high school is near impossible for most. Expansion International provides scholarships of \$350 to help students from the Ndumberi children center and the Kieni refugee village acquire an education that will make them employable, allow them time to mature so they can make better life choices and give them the education that enables them to live a more fulfilling and productive life.

Water Programs - In Kenya many people suffer from water-borne diseases that become chronic due to lack of access to clean water. Expansion International completed a project to take clean water from an existing well at the Mercy Medical Center to three other points of access in the community.
