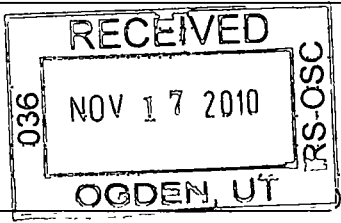

THE PURPOSE OF THE FOUNDATION IS TO STRENGTHEN THE RESOLVE AND STAMINA OF CANCER PATIENTS BY GIVING THEM THE OPPORTUNITY TO BE REMOVED FROM THE GRIND OF DAILY LIFE FOR A SHORT TIME AFTER RECEIVING CANCER TREATMENTS, SUCH AS CHEMOTHERAPY AND RADIATION.
