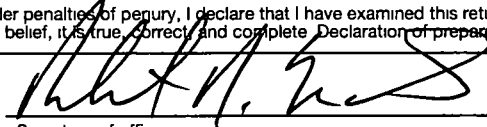

Part III – Statement of Program Service Accomplishments

What is the organization's primary exempt purpose?

The primary purpose of Children From Afar, Inc. (CFA) is orphan advocacy. Activities of CFA are to meet the humanitarian (e.g. food, clothing, housing & medical) and educational needs of orphans around the world. As an additional activity for orphan advocacy, CFA will also assist in the adoption of orphans by providing financial assistance to offset documented adoption costs.
