

HANCOCK HOUSING RESOURCE CENTER PROVIDED COUNSELING AND COORDINATION SERVICES TO INTERNATIONAL RELIEF AND DEVELOPMENT AS A SUBCONTRACTOR FOR THE MISSISSIPPI ALTERNATIVE HOUSING PROJECT (MAHP). HRC'S RESPONSIBILITY INCLUDES INTAKE, ELIGIBILITY DETERMINATION, COORDINATION OF PURCHASE, COLLECTION OF FUNDS AND FACILITATION OF CLOSING. HRC MANAGED 703 CLIENTS IN THIS PROGRAM. THE COMING HOME COLLABORATIVE IS A KCDBG FUNDED REHAB AND REBUILD PROGRAM RELATED TO KATRINA. HRC IS THE HANCOCK COUNTY HOUSING PARTNER PROVIDING THE DIRECT CLIENT SERVICES OF INTAKE, ELIGIBILITY DETERMINATION, CASE MANAGEMENT AND CONSTRUCTION COORDINATION. DURING 2009, HHRC RECEIVED 185 APPLICATIONS FOR THE PROGRAM, SCREENED APPROXIMATELY 300 ADDITIONAL FILES FOR ELIGIBILITY. EIGHTY FAMILIES COMPLETED THIS APPLICATION PROCESS. TWENTY-ONE FILES WERE SUBMITTED FOR ENVIRONMENTAL ASSESSMENT. APPROXIMATELY THIRTY CLIENTS WERE TRANSFERRED INTO THE LONG-TERM RECOVERY PROGRAM BECAUSE THEY WERE INELIGIBLE FOR FUNDING UNDER THIS PROGRAM.

THE LONG-TERM RECOVERY PROGRAM IS FUNDED BY NUMEROUS SOURCES. HRC PROVIDES INTAKE, CASE MANAGEMENT, ELIGIBILITY DETERMINATION, PROJECT SCOPE DEFINITION, CONSTRUCTION ESTIMATION, VOLUNTEER COORDINATION, CONSTRUCTION COORDINATION, FUNDING AND OTHER COUNSELING-RELATED ASSISTANCE FOR FAMILIES IMPACTED FROM HURRICANE KATRINA THAT HAVE NOT BEEN ABLE TO RECOVER WITHOUT ASSISTANCE. AT THE END OF 2009, HRC HAD ABOUT 450 OPEN CASES REQUESTING HELP WITH REBUILD OR REHAB OF THEIR HOMES. HRC PROVIDED CONSTRUCTION MANAGEMENT, VOLUNTEER COORDINATION AND/OR ACCESS TO NON-PROFIT FUNDING TO COMPLETELY REBUILD 51 HOMES AND REHABILITATE 36 HOMES. THIS WAS ACCOMPLISHED THROUGH PARTNERSHIPS WITH MORE THAN 20 OTHER DISASTER-RELIEF ORGANIZATIONS. MORE THAN 5,465 VOLUNTEERS PROVIDED 171,048 HOURS OF VOLUNTEER HELP TO REBUILD THESE
