



(Revenue \$) UCSD ACADEMIC CONNECTIONS - REALITY CHANGERS STUDENTS WHO ACHIEVE A 3.5 GPA QUALIFY TO ATTEND ACADEMIC CONNECTIONS, AN INTENSIVE, THREE-WEEK RESIDENTIAL PROGRAM OFFERED EACH JULY BY UC SAN DIEGO. AT ACADEMIC CONNECTIONS, REALITY CHANGERS STUDENTS TAKE REAL COLLEGE CLASSES AND EARN REAL COLLEGE CREDIT BEFORE EVEN BECOMING SOPHOMORES IN HIGH SCHOOL, THUS CONVINCING THEM THAT THEY CAN ACHIEVE SUCCESS AT A HIGH ACADEMIC LEVEL. THE REGULAR COST FOR ACADEMIC CONNECTIONS IS APPROXIMATELY \$3,500 PER STUDENT, \$2,500 WAS PAID BY REALITY CHANGERS FOR 44 STUDENTS. UC SAN DIEGO PROVIDED \$1,000 DISCOUNTS FOR THE 44 REALITY CHANGERS STUDENTS IN 2009.

THIS WEEK-LONG SUMMER CAMP ALLOWS STUDENTS TO MAKE TRANSFORMATIONAL DECISIONS THAT WILL IMPACT THEIR DAILY LIVES BOTH INSIDE AND OUTSIDE OF THE CLASSROOM. THE REGULAR COST FOR FOREST HOME IS APPROXIMATELY \$500 PER CAMPER AND THANKS TO DISCOUNTS GRANTED BY FOREST HOME, REALITY CHANGERS PAID APPROXIMATELY \$220 PER STUDENT FOR 91 STUDENTS IN 2009.
