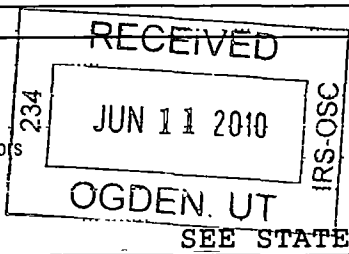

THE MINISTRY TARGETS SENIORS GRADUATING HIGH SCHOOL WHICH MAY BE STRUGGLING IN VARIOUS AREAS. THESE STRUGGLES CAN INCLUDE FINANCIAL, EMOTIONAL, LIFE SKILLS, ETC. 360 BIRMINGHAM PROVIDES AN ENVIRONMENT TO ENABLE THESE MEN TO BECOME DISCIPLES. DURING IT'S 2009 INAUGURAL YEAR, 360 BIRMINGHAM ESTABLISHED ITS FIRST CLASS (CURRENTLY 3 PARTICIPANTS). WE RECRUITED TWO HOUSE PARENTS TO HELP DEVELOP, LOVE, AND PROVIDE FOR THESE PARTICIPANTS. THROUGH GENEROUS DONATIONS, 360 BIRMINGHAM SPENT MORE THAT \$36,000 DURING 2009 ON HOUSING, FOOD, EDUCATION, AND OTHER GENERAL NECESSITIES. IN ADDITION TO FINANCIAL NEEDS, THE ORGANIZATION PROVIDED OTHER BENEFITS TO PARTICIPANTS SUCH AS TUTORING, BIBLE STUDIES, AND LIFE SKILL CLASSES.
