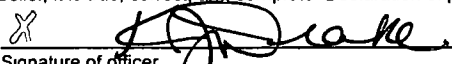
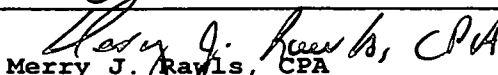

To teach rural African farmers how to build and maintain wind-powered water pumps for irrigating farm lands, propogating advanced sustainable irrigation and farming techniques in Southern Africa.

Developed a windmill that could be made entirely out of locally available free materials so that every African smallholder farmer could have access to the technology. Installed the first prototype windmill in the Village of Mgwai, Malawi. Consulted with local African agriculture and irrigation professionals and obtained support for the windmill as a viable solution for the country. Africa Windmill Project, Inc. is partnering with agencies in Africa and U.S. organizations providing services in Africa to expand the installation and use of the windmill to propogate sustantainable irrigation and farming techniques in Southern Africa. Approximately 725 volunteer program service hours have been contributed for this program.
