Fair Food Detroit A project where we work collaboratively with community organizations and funders in Detroit and Southeast Michigan to create increased access to healthy and sustainably grown food for residents while also supporting local agriculture and food systems We piloted a successful project in late 2009 called Mo' Bucks Double Value Coupon at Detroit's Eastern Market that 1) provided incentives for families who receive food assistance benefits (Supplemental Nutrition Assistance Program [SNAP], also known as food stamps) to spend those funds on healthier food by increasing their purchasing power for fresh fruits and vegetables, and 2) supported the local food economy, which includes traditional farmers and urban gardeners as well as locally owned small groceries and farm stands
