


ONE IS THE DIRECTOR OF THE BIBLE SCHOOL WHICH WE SUPPORT, ONE MANAGES CAMP EDEN, A CHURCH CAMP, AND ANOTHER LEADS A CHILDREN'S MINISTRY. OUR GOAL IS TO PROVIDE ENOUGH FINANCIAL SUPPORT SO THESE PEOPLE DO NOT NEED TO WORK FULL TIME OUTSIDE OF THE CHURCH AND ARE THEREFORE ABLE TO SPEND A SIGNIFICANT PART OF THEIR TIME GROWING THEIR CHURCHES AND MINISTRIES.

WE ALSO CONTINUE TO SUPPORT A BIBLE SCHOOL FINANCIALLY AND SENT A VOLUNTEER PROFESSOR TO TEACH SOME COURSES THERE AS WELL. WHILE LEARNING TO LEAD MINISTRIES THE STUDENTS ARE ALL INVOLVED WITH A VARIETY OF MINISTRIES INCLUDING: YOUTH, CHILDREN'S WORSHIP AND CAMP MINISTRIES TO NAME A FEW.
