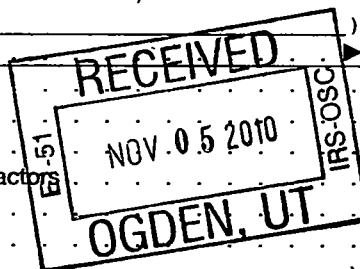

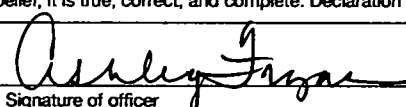

PROJECT 82 KENYA STATEMENT OF PROGRAM SERVICE ACCOMPLISHMENTS

The primary purpose of Project 82 Kenya is to serve widows, orphans and vulnerable individuals living in rural Kenya, Africa, by providing for both their physical and spiritual needs including but not limited to the provision of clean water, nutritionally balanced meals, improved housing, quality medical care, educational opportunities, and spiritual discipleship.

In 2009, the Executive Director of Project 82 Kenya conducted two vision trips to Kenya for the purpose of exploring ministry opportunities in several different geographic locations of rural Kenya. The visioning process included meeting local leadership in each community to learn about the history of the community as well as the current situation and priority needs for each community.

In September we visited 4 potential partner communities in the Laikipia District. The region was experiencing a severe drought during this time so Project 82 provided maize and beans for the orphans in the villages that we visited. In December, we visited 7 additional villages which ultimately led to the ministry locations we are today.
