This includes, but is not limited to, Mental Health Services, Dental, Pediatric and Immunization Clinics, Emergency Assistance, Job Counseling and Placement, Food Pantry, and Women, Infants and Children Services. These programs have served over 4,000 people in the past year.

Mother-Daughter/Father-Son Program: La Plaza's Mother-Daughter/Father-Son Program empowers middle school Latinos to continue their education through high school and beyond by helping them value the importance of education, develop self-esteem and leadership skills, shatter myths and stereotypes, foster supportive and enduring relationships, and explore future dreams and goals. The program also works with parents to help give them the tools to contribute to their child's education.

Tu Futuro: La Plaza's Tu Futuro program is an educational program dedicated to encouraging and supporting Latino youth and non-traditional students to pursue a post-secondary education. This is achieved through a series of bilingual presentations, workshops, individual consultations, and college visits. Students are provided information about the college application process, financial aid, and scholarship programs. This program has served over 1,700 students this past year.
