THE PROGRAM'S AIM IS TO CREATE THE LARGEST ONLINE COMMUNITY OF CONSERVATIONISTS AND CONCERNED PEOPLE WHO ARE WILLING TO SUPPORT CONSERVATION IN THIS AREA.
