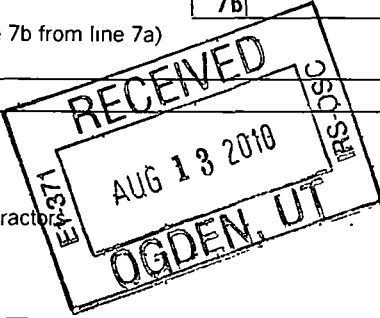

2009 Tax Return Community Activities

In 2009, the Winged Foot Foundation was actively involved in the community. The WFF achieved its goal of assisting student athletes in the Chicago area by offering goods and programs to help strengthen educational and sports activities in their communities. Providing motivational speeches by mentors, promoting family appreciation events, donating sports equipment, organizing sports events and promoting higher education were the primary functions of the WFF.

January and February

- Over 500 pair over running shoes, clothes and equipment were distributed to 8 high schools in the Chicago area.
- Mentoring speeches were given to 4 high school track teams
- Trophies purchased for Parents Appreciation Night Banquet

March

- The WFF hosted the annual Parents Appreciation Banquet at Thornton High School in Harvey, Illinois. Over 300 students and their parents were treated to: a catered dinner, trophies, running gear, and a motivational speech by a guest speaker, (Steve Toth, Asst Principal and Head Track & Field Coach, Thornton High School, 1970-79).

April & May

- Mentoring – motivational speeches were given to 4 high school track teams
- Over 50 pair of racing spikes were distributed to 8 high schools In January and February
- Over 200 pair over running shoes, clothes and equipment were distributed to 10 high schools in the Chicago area.
