


What is the organization's primary purpose?

Heshima is a Swahili word that means "dignity". Heshima provides 'dignity' for physically and mentally handicapped children with cerebral palsy, brain damage and other disabilities in the slum village of Ngando in Nairobi, Kenya. Heshima children receive physical and occupational therapy three times a week to improve their motor skills and speech therapy once a week to improve their communication skills. Therapy is provided by a small but growing staff of expatriate and local therapists. An important form of therapy is horse riding, which strengthens children physically and improves their balance and coordination. In addition to therapy, Heshima offers those at its center nutrition, both breakfast and lunch, and medical interventions through local doctors and nurses.
