Ambulance service for veterans living in Clark County, Ohio in cooperation with the Clark County Commission. This service is provided free of charge to any veteran who needs transportation to the Dayton or Cincinnati Veteran Hospitals, regardless whether the veteran is a member of the VFW or not. Ambulance service was provided on 246 days in 2009 and it is estimated that 286 veterans were transported via ambulance.

Veteran remembrance activities include participation in parades for Memorial Day, Fourth of July, Veterans Day, etc., participating in the opening ceremonies of the Clark County Fair, recognizing and promoting various holidays associated with veterans (Memorial Day, Veterans Day, Fourth of July, Flag Day, Armed Forces Day, and Patriot Day), and honoring deceased veterans with a ceremony at their funeral and providing the family of the deceased veteran with a United States flag which is draped over the veteran's casket until the conclusion of the graveside service. It is estimated that 900 to 1125 flags were used in 2009 to honor our deceased veterans as their final thank you from a grateful nation.

High school R.O.T.C. programs in Clark County, Ohio are partially supported by the VFW with assistance from the various branches. The VFW provides flags, written resources, and advisors to the programs. The VFW solicits VFW members to speak with the youths participating in the programs about their military experiences, especially combat roles. It is estimated that 165 high school students participated in R.O.T.C. programs in Clark County in 2009. Through the programs, the participants learn about the military and develop leadership skills. For many, especially those from economically disadvantaged homes, this may be their only opportunity for such experiences.
