Statement of Principles Grants may be made to charitable organizations in the Miami County Region (includes counties contiguous to Miami County) and central Ohio. Special emphasis will be placed on grants to charitable organizations in the Miami County Region. Generally, 75 percent of available grantmaking funds shall be designated for use in the Miami County Region and 25 percent of available grantmaking funds shall be designated for use in central Ohio. In the event that there are insufficient acceptable requests from the Miami County Region to reach the designated 75 percent, excess funds will be reserved for future disposition in the Miami County Region. This Statement underscores the Foundations roots in Miami County, however, the Board may in its discretion authorize grants to charitable organizations outside the Miami County and Central Ohio regions. The Foundation will honor Paul Dukes concern for children, families, and the most needy members of society.
