The Homeless Families Foundation (HFF) makes a difference in the lives of families through programs that provide the stability needed to acquire jobs, housing, and a chance at a better life. HFF has 46 fully furnished apartment shelter units. We provide case management to help our families regain support and stability on their paths to permanent housing. In 2009, HFF served 179 families and 393 children with 79% of the families finding and maintaining their own housing. The average monthly income of our incoming families is \$263. The average length of stay at our shelter is 112 days.

The HFF has a strong focus on helping children succeed in school and life by providing an after-school and all-day summer program for school-age children. In 2009, the Dowd Center served 155 school-age children and provided tutoring, enrichment, homework assistance and recreational activities. The Dowd Center collaborates with many community organizations to provide the enrichment opportunities for our children. We have a secure playground with age appropriate equipment, basketball courts, picnic tables and benches.
