Grants to support services for at-risk children and families

The Ohio Children's Foundation awarded \$384,414 in grants, ranging from \$100 to \$30,000, to more than 100 organizations working to improve the health and welfare of children and their families. The Foundation continued its tradition of supporting programs for children whose circumstances have made them vulnerable, at risk, or unlikely to receive services without our help.

School Readiness

The Foundation administered a kindergarten readiness program that builds trust and communication between schools and families even before children enter kindergarten. A total of 320 teachers and other school professionals made home visits to 2,298 families with incoming kindergarteners in 6 school districts in Franklin County. These visits relieve the anxieties, fears and other stresses associated with a child's going to school for the first time. The Foundation replicated the program in disadvantaged schools in Appalachian Ohio, including Athens, Pike, Belmont, and Columbiana counties.
