

New Ranch Network which is a grants program supporting a network of ranchers, scientists, consultants, conservationists, volunteers, and others who assist ranchers or other landowners in "making the leap" to progressive

4c (Code:) (Expenses \$ 176,935. including grants of \$ 7,500.) (Revenue \$) Mentoring and Capacity Building - Quivira assists the Ojo Encino Chapter of the Navajo Nation to expand their efforts to build economic and ecological resilience. Principally, this is done by helping the Chapter develop the capacity to plan and implement 1) ecological grazing and agrarian projects, 2) managed livestock grazing, and 3) a proactive feral horse management program. Also includes CARLY program (Conservation and Ranch Leadership and Youth) - program to create apprentice and internship opportunities for the next generation of conservation and agrarian leaders.


