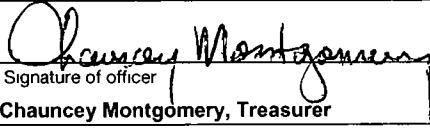
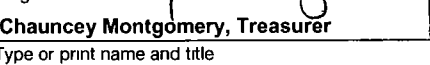

Value of shares in RVS Disciplined Equity Fund, Account 0010 1225 6925 3 002, decreased throughout 2009, ending at 4.73 per share. The fund's principle value increased approximately \$5,036 over the course of 2009. The year end value was \$34,820.33.

Value of shares of Delaware County Bank and Trust stock decreased to \$9.40 per share. The stock lost about \$60, decreasing the total value to \$160.

Ralph Gooding Local Charity Fund FBO Community Library Foundation, Inc, Account 21 08 1003 0 01, decreased in market value \$7,061, resulting in a balance of \$61,794.

The total value of these increases in net assets, minus the dividends paid and investment income earned during the year, is \$12,037.
