GREATER LINCOLN CHAMBER FOUNDATION RECEIVED SIGNIFICANT CONTRIBUTIONS FROM SOME LARGE LOCAL ORGANIZATIONS EARLY IN THEIR EXISTENCE. THOSE CONTRIBUTION SOURCES HAVE SUBSEQUENTLY DWINDLED AND HAVE BEEN REPLACED BY INVESTMENT INCOME ON THE CONTRIBUTED ASSETS. HOWEVER, GREATER LINCOLN CHAMBER FOUNDATION HAS RECEIVED SMALLER CONTRIBUTIONS FROM THE SAME UNRELATED ENTITY OVER THE PAST 2 YEARS. THE EXCLUSION OF THESE CONTRIBUTIONS FROM THEIR PUBLIC SUPPORT TEST, ALONG WITH THE DECREASE IN TOTAL CONTRIBUTIONS AND INCREASE IN INVESTMENT INCOME, HAS LED TO A DECREASE IN THEIR PUBLIC SUPPORT PERCENTAGE. GREATER LINCOLN CHAMBER FOUNDATION HAS BEEN USING INVESTMENT INCOME TO CONTINUE IN THEIR EXEMPT PURPOSE WHILE THEY TRY TO RAISE THE NECESSARY CONTRIBUTIONS TO INCREASE THEIR PUBLIC SUPPORT PERCENTAGE. GREATER LINCOLN CHAMBER FOUNDATION IS IN COMPLIANCE WITH ALL OTHER RULES AND REGULATIONS FOR EXEMPT ORGANIZATIONS AND HAS CONTINUED TO USE THEIR ASSETS TO FULFILL THEIR EXEMPT PURPOSE.
