LifeCare Alliance's mission is to lead the community in identifying and delivering health and nutrition services to meet the community's changing needs. In 2009, LifeCare Alliance served nearly 15,000 clients: 71% female, 42% minority, 62% age 65 or older, 65% with annual incomes of less than \$20,000

Meals on Wheels provides nourishing food and a daily visit to homebound, older, disabled, and chronically ill adults 365 days a year. Meal options include hot, cold, frozen, diet, kosher, vegetarian, pureed and mechanical soft, along with dietary specialty meals. The MOW program serves as many as 6,000 meals a day, including meals for kids in day care and after school programs. In 2009, volunteers and staff delivered 863,495 meals in Franklin and Madison Counties to 4,274 clients. Meals-for-Kids Program delivers meals to after-school care sites for school age children and to daycare centers and charter schools. Meals-for-Kids provided more than 229,063 meals in 2009. Senior Dining Centers provide meals for older, disabled and chronically ill adults at community dining centers and restaurants in over twenty locations across central Ohio, including culturally diverse meals at four Asian and Somali restaurants. Transportation is available to most locations. Dining centers offer socialization, enrichment programming and a nutritious meal with the purpose of increasing the number of central Ohioans who achieve a higher level of successful aging, maintenance of high cognitive and physical functioning and engagement with life. In 2009, the program served 176,409 meals to 3,628 clients

Help-at-Home program provides homemakers and home health aides who assist with daily living activities, bathing, fall prevention, and basic household chores. The Help-at-Home staff works with a network of community contacts to assure appropriate client services are assessed. In addition, Help-at-Home coordinates home repair projects for clients in need of safety and health related repairs such as repairing electrical or plumbing issues, installing grab bars and railing, repairing floors and drywalls. In 2009, the program provided 29,692 hours of homemaker and/or home health aide services to 452 clients. In addition, 62 homes were repaired.

Wellness Services provides health care services in community wellness centers throughout Franklin County. The community wellness centers are located in areas where the population is under-served, has limited access to health care and/or has limited financial resources. Services include, but are not limited to, health assessments, skilled nursing care and screening tests with a focus in health promotion and education, disease prevention and chronic disease management. In addition to the registered nurses, the wellness program employs registered dietitians who provide medical nutrition therapy, weight management programs, diabetes self management and educational programs on a wide variety of nutrition topics. The wellness team also provides health care services in the corporate setting. Health fairs for community organizations and businesses are a recent addition to the wellness program. In 2009, the nurses and dietitians provided services to 1,086 clients in the community wellness centers

Visiting Nurse Association (VNA), a Medicare/Medicaid certified service, provides skilled care in the home to patients recovering from illness, injury, surgery or managing chronic health conditions. VNA integrates its services with client service providers such as occupational therapists, physical therapists, dietitians, pharmacist, and social workers

Columbus Cancer Clinic (CCC), a Medicare certified service, provides education about cancer prevention, head-to-toe cancer screenings and examinations and mammograms regardless of ability to pay. In 2009, the program served 3,695 clients providing 2,624 mammograms and head-to-toe cancer screenings, and 664 clients with home care support services. In addition, the program provides low-income, under insured or uninsured individuals living with active cancer related medical appointments, pantry items, nutritional supplements and emergency financial assistance to those home care support patients who are about to lose daily necessities such as housing and/or utilities

Project OpenHand-Columbus (POHC), provides home-delivered nutritionally enriched meals, pantry items, nutritional supplements, nutritional assessments and counseling and a congregate meal program to men, women and children living with HIV/AIDS in central Ohio. In 2009, POHC provided 27,375 home-delivered meals to 130 clients, served over 150 congregate meals as well as provided 9,846 bags of groceries to 472 clients

L A Catering, a social entrepreneurship, offers full service off-site catering using the culinary expertise of LifeCare Alliance kitchen staff working from the kitchen facility at 1699 West Mound Street. LifeCare Alliance also have other contract services
